3.0 PAY SCALE: Rs. 35400/- initial Pay.

4.0 ESSENTIAL QUALIFICATIONS :-

4.1	(i) Should possess Diploma/Degree in Electrical Engineering of a recognized Institution.
4.2	(ii) Punjabi of Matric or its equivalent Standard.

5.0 AGE

Candidates should not be below 18 years and above 37 years of age as on **01.01.2021** (See detail in General Information for candidates).
